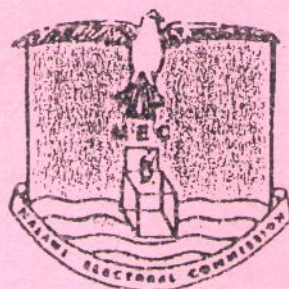

Report to Parliament by the Electoral Commission

The Number of Parliamentary Constituencies

and the Boundaries of each Constituency

BLANTYRE
7th JANUARY, 1999

Introduction

(1) Appointment and Composition of the Electoral Commission

The current Electoral Commission was appointed by His Excellency the President on 1st July, 1998. The appointment was in terms of Section 75 of the Constitution as read with Section 4 (1) of the Electoral Commission Act No. 11 of 1998 which provides that the President shall, subject to the Constitution and in consultation with the Leaders of the political parties represented in the National Assembly, appoint suitably qualified persons to be members of the Commission on such terms and conditions as the Public Appointments Committee of Parliament shall determine. Those appointed by His Excellency the President were:

(2) Mandate of the Electoral Commission on Demarcation

In addition to the broad functions and powers conferred on the Commission by the Constitution and, subject to the Constitution, the Commission is required to exercise general direction and supervision over the conduct of every election and, without prejudice to the generality of such

functions and powers; it shall have the following further functions, among others:

- (a) to determine the number of constituencies for the purposes of elections;
- (b) to undertake or supervise the demarcation of boundaries of constituencies;
- © to review existing constituency boundaries at intervals of not more than five years and alter them in accordance with the principles laid down in the Constitution.

(3) **Activities Undertaken To Date**

Upon its assumption of duties on 1st July, 1998 the Electoral Commission undertook a number of activities in preparation for the 1999 Parliamentary and Presidential General Elections:

- (I) It immediately set up eight committees namely: Finance and Administration; Civic and Voter Education; Training; Campaign Monitoring; Media and Public Relations; Operations and Logistics; Legal Affairs and Voter Registration and Demarcation.
- (ii) The Commission has prepared a budget which is to be funded by the donor community and the Malawi Government.
- (iii) It has recruited its own Chief Elections Officer and other subordinate staff following the passage of the Electoral Commission Act which delinks the Commission Secretariat from that of the National Assembly. This move has enhanced the autonomous nature and independence of the Commission.

- (iv) Some commissioners have attended workshops and seminars on electoral matters in a number of countries; and the Chairman participated in an election observation mission to Germany early in September, 1998.
 - (v) The Commission has prepared an election calendar for the 1999 General Election. All arrangements being in order regarding funding for printing of the registration forms, receipts and certificates, provision of Polaroid cameras and forms together with other registration materials i.e. registration kit, the voter registration exercise is scheduled to start on 1st February, 1999.
 - (vi) The Commission finally undertook a familiarization and fact - finding district - by - district tour of the whole country.
- (4) **Assistance From International Foundation for Election Systems- Building a Demarcation Infrastructure Project/ Malawi**

The Commission has been greatly assisted by the USAID funded IFES Malawi/BDI Project , which made available consultants like Joe Baxter, IFES Senior Advisor for Election Administration based in Washington DC, and Vic Butler, a British-based Elections Consultant. They together with Dr. D. Gajadhar a Commonwealth Consultant inducted the newly appointed Commissioners to specifics of election management and administration as they are commonly applied. They supplied pamphlets and election materials for them to study step by step elements of electoral process and also helped to prepare the election calendar.

The IFES Consultants also prepared the Report On Issues In Preparation For The 1999 General Elections in Malawi. The report resulted from their visits to fourteen districts in Malawi. During the visits the consultants were accompanied by some former Commissioners. That Report was made available to the new Commissioners who found it to be very useful and enriching.

(5) **District-level Consultations**

The Electoral Commission undertook a tour of all the 26 districts in the three regions of the country starting from 7th October, 1998, and ending on 21st November, 1998 punctuated with breaks in between.

Meetings were arranged through District Commissioners and those who attended included representatives of political parties, Members of Parliament, Traditional Leaders, Government officials, members of the civil society and other stakeholders. It may be pleasing to note that these briefing sessions were well attended and adequately represented.

The objective of the visits was, apart from briefing the stakeholders at district level on preparations for the 1999 Parliamentary and Presidential General Election, for the Commission to consult with the stakeholders regarding the issue of re-demarcation of some constituencies where necessary.

In accordance with Section 76(2) of the Constitution, the Electoral Commission must review existing constituency boundaries at intervals of not more than five years and alter them in accordance with the principles laid down in Section 76 (2) (a) as follows:

“ to determine constituency boundaries impartially on the basis of ensuring that constituencies contain approximately equal numbers of voters eligible to register subject only to considerations of -

- (I) population density;
- (ii) ease of communication; and
- (iii) geographical features and existing administrative areas;”

During the meetings, the Commission was able to explain to the district stakeholders, the constitutional requirements about re-demarcation and therefore, outlined the criteria cited above. In addition to the above criteria, it was explained that while the Commission was mandated to increase or reduce constituencies, its recommendations were but subject to confirmation by the National Assembly. The meetings were also informed that a detailed demarcation exercise regarding constituency boundaries would be conducted by the Commission in the post - election period by using Surveyors from the private sector and the Surveys Department. However, an appeal was made to the meetings that they urgently submit proposals especially in cases where their present members of Parliament were failing to adequately service their constituencies due to over population, inaccessibility, geographical features, etc.

(6) Factors Influencing Present Proposals

In the 1993 demarcation exercise, the Commission appeared to have placed less weight on the criterion that constituencies should contain approximately equal numbers of voters eligible to register. It also chose not to draw constituency boundaries that crossed regional or district boundaries. The previous Commission Report further gave a great deal of consideration to

geographical areas and sub-divided large constituencies rather than re-demarcating all constituencies within many districts. This resulted in the smallest constituency i.e. Nkhata Bay East having only 3,407 registered voters and the largest constituency i.e. Machinga North having 59,494 registered voters. This meant that the votes of the people of Nkhata Bay East had 17 times more value than the people of Machinga North in the National Assembly. For the 1999 elections, the Electoral Commission is proposing to re-demarcate the boundaries of the constituencies in accordance with Section 76(2) (b) of the Constitution.

In the Commission's present proposal to re-demarcate the constituency boundaries for the 1999 elections, it has addressed several factors that are important to the people of Malawi but which may be somewhat inconsistent with the principle of political equality and constituencies of approximately equal populations. These and other factors which influenced the Commission's recommendations are:

- (I) Lack of understanding among political leaders and the general population of the political equality principle as it applies to representation in the National Assembly. In discussing with the local political leaders, Government officials, Traditional Authorities, civil society, etc. the Electoral Commission was struck by the lack of understanding of the principle of political equality when applied to Malawi. Most of the people consulted earlier by the IFES team established that their district should not lose any constituencies. In fact, most felt that more constituencies should be created in their areas.

- (ii) That large areas of the country which are sparsely populated and virtually inaccessible by land;
- (iii) Large areas of the country have poor communication infrastructure. In most districts visited, the size of the current constituencies and the lack of transportation and communication infrastructure were the two important reasons most cited by the people. There was overwhelming feeling that geography and communications should be the standard by which constituencies should be re-demarcated.
- (iv) Views of Traditional Authorities were also of paramount importance. It is important and realistic to recognize that Traditional Authorities have the capacity to disrupt the election process if their views or demands were not properly addressed. Some Traditional Leaders were openly resistant to sharing a member of Parliament or having his/her traditional area split into two or more constituency areas.
- (v) The Commission has also considered and taken into account the 1994 voter registration statistics and in the absence of the September, 1998 Census figures as a basis for re-demarcation. See Appendix I for ease of reference.
- (vi) Due to shortness of time before the forthcoming General Elections in May, the Commission is unable to review all constituency boundaries in the country and has therefore placed greater emphasis on factors regarding the size of the current constituencies, lack of transportation and communications infrastructure, population density and views of

Traditional Authorities in coming up with the recommendations in this Report. However, the Commission proposes that after the General Elections, arrangements will be made for a nationwide comprehensive review of all the constituency boundaries together with local government wards using the established criteria and also produce constituency boundary maps.

- (vii) For this report, the absence of constituency boundary maps is due to the fact that a number of District Commissioners, when submitting proposals from their districts, did not send maps to specify clearly the boundaries of the proposed constituencies vis-a-vis the existing constituencies from which the proposed constituencies have been created.

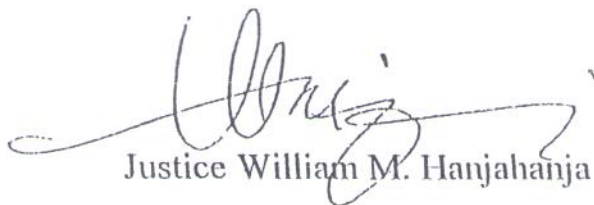
- (viii) The population figures used in this report are based on the number of registered voters as recorded in the 1994 Parliamentary and Presidential Elections Report and data from the 1998 population and housing census.

(7) **Conclusion**

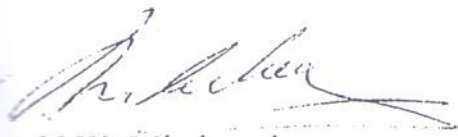

The aim of the Commission is to enhance the sustainability of the country's young democracy in the interest of good governance and national development.

Towards that end, the Commission is putting in place appropriate mechanisms regarding the conduct of these elections starting with registration of voters, campaigning, nomination of candidates and polling to ensure free, fair and credible elections.

The Commission would like to express special thanks to the IFES and Commonwealth consultants for their valuable assistance. It also wishes to commend the cooperation and support it received from district stakeholders during its nationwide consultations. The views from the Traditional Authorities, political party leaders, Members of Parliament, Government officials and members of the civil society were very helpful to the Commission in making its decision and for which the Commission is very grateful. And finally, the Commission expresses its deep gratitude for the devoted assistance it received from its Secretariat in preparing this Report.



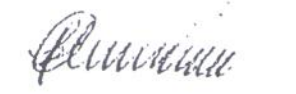

CHITIPA

Number of Registered Voters (1994) - 53,462

Number of Estimated 1998 Population - 125,619

Number of Eligible Voters (18 years +) - 56,867

The Commission visited Chitipa District on 19th October, 1998, in order, among other things, to review the constituency boundaries. There are currently five constituencies in the district. The local leaders have asked for two additional constituencies out of Chitipa East and Chitipa Central constituencies citing rugged topography, high population and vastness of area, respectively, as reasons for the request.

Having considered the requests, the Commission prescribes that the constituencies in Chitipa District should be delimited as follows -

(a) **Chitipa Misuku East**

The eastern part of Chitipa District comprising the area of Chief Mwenemisuku up to Wilindi Forest Ridge.

(b) **Chitipa Misuku West**

The western part of the area of Chief Mwenemisuku starting from Wilindi Forest Ridge.

(c) **Chitipa Bulambya North**

Created from the current Chitipa Central and Chitipa North constituencies.

(d) **Chitipa Bulambya South**

Created from the current Chitipa Central constituency and now excludes the North Council Ward of Chief Mwaulambya formerly under the old Chitipa North Constituency.

(e) **Chitipa Kameme** (Old Chitipa North)

The northern part of Chitipa District comprising the whole area of Chief Kameme and excluding the North Council Ward of chief Mwaulambya.

(f) **Chitipa Wenya**

This constituency comprises the whole area of Chief Mwenewenya and remains the same.

(g) **Chitipa Nthalire**

The southern part of Chitipa District comprising the area of Chief Nthalire and remains the same.

KARONGA

Number of Registered voters- 84,501

Number of Estimated 1998 Population - 194,275

Number of Eligible Voters (18 years +) 92,124

The Commission visited Karonga District on 20th October, 1998, in order, among other things, to review the constituency boundaries. There are currently five constituencies in the district. The local leaders have asked for two additional constituencies out of Karonga North and Karonga North West citing high population and communication problems, as reasons.

Having considered the requests, the Commission prescribes that the constituencies in Karonga District should be delimited as follows:-

(a) **Karonga South**

The southern part of Karonga District comprising the areas lying between Vinthukutu School drawing a straight line due west through Vinthukutu Forest to the edge of Nyika National Park and Chitimba River in Chief Wasambo's area including Vinthukutu School.

(b) **Karonga Nyungwe**

This constituency comprises the areas lying between Vinthukutu School and

Gumi Stream in Sub Chief Mwirang'ombe.

(c) **Karonga Central**

The central part of Karonga District comprising the area of Chief Kyungu from Lwasho to Ntchowo.

(d) **Karonga North**

The northern part of Karonga District comprising the area from Ngaramu to Ngana.

(e) **Karonga Ngerenge**

The Northern part of Karonga District comprising the area from Ntchowo to Ngaramu including the boundaries of Sub - Chief Mwakaboko and Chief Kilupula.

(f) **Karonga Filauli**

Comprising the area from Mkungwe to Wilira on the road up to Chitipa border.

(g) **Karonga Lupembe**

The former Karonga North West constituency from Lwasho to Ntchowo

RUMPHI

Number of Registered Voters- 62,273

Number of Estimated 1998 Population - 128,274

Number of Eligible Voters (18 years +) -62,501

The Commission visited Rumphi District on 21st November, 1998, in order among other things, to review the constituency boundaries. There are currently four constituencies in the district. The local leaders have asked for one additional constituency citing size of the area, geographical and communication problems, as reasons.

Having considered the request, the Commission prescribes that the constituencies in

Rumphi District should be delimited as follows:-

(a) **Rumphi East**

The eastern part of Rumphi District comprising the whole area of Chief Mwamlowe, Sub- Chief Chapinduka and the lakeshore area of Sub- Chief Mwalweni including Jalawe in the hilly areas.

(b) **Rumphi Central**

The central part of Rumphi District comprising part of sub-chief Mwahenga from Mhuju area in Sub-Chief Mwankhunikira and part of Chief Chikulamayembe which is in the Henga Valley including the Boma area up to Lunyina River.

(c) **Rumphi West**

The western part of Rumphi District comprising the whole of T.A. Katumbi, STA Zolokera and part of T.A. Chikulamayembe up to Khankha Stream at Chitanga.

(d) **Rumphi Nkhamanga**

Proposed new constituency comprising the area from Luviri River bordering the Central constituency and Khankha Stream.

(e) **Rumphi North**

The northern part of Rumphi District comprising the areas of Sub-Chief Kachulu and part of Sub-Chief Mwalweni in Phoka area and part of Sub-Chief Mwahenga up to Mhuju including Livingstonia Mission Station.

NKHATA BAY

Number Registered Voters- 72,051

Number of Estimated 1998 Population -171134

Number of Eligible Voters (18 years +) 84,600

The Commission visited Nkhata Bay District on 21st October, 1998, in order, among other things, to review the constituency boundaries. There are currently seven constituencies in the district. The local leaders have asked for two additional constituencies citing vastness of areas of existing constituencies and difficult terrain as reasons.

After considering the request, the Commission is of the view that the constituencies in Nkhata Bay District should remain as at present. The only change will be a new boundary between Nkhata Bay South and Nkhata Bay South East constituencies along Kande River.

The Commission therefore prescribes that the constituencies in Nkhata Bay District should be as follows:

(a) **Nkhata Bay North**

The northern part of Nkhata Bay District comprising the areas of Sub-Chief Mkondowe, Chief Boghoyo, Chief Musisya and Sub-Chief Nyaluwanga.

(b) **Nkhata Bay East**

The eastern part of Nkhata Bay District comprising Chizumulu and Likoma Islands in Chief Mkumpha's area.

(c) **Nkhata Bay Central**

The central part of Nkhata Bay District comprising the whole area of Sub Chief Mkumbira and that part of Chief Timbiri lying between Kandoli mountains and the Lake. From Limphasa bridge on the Mzuzu-Nkhata Bay road draw a straight line due North East to the top of Kandoli mountains range and follow these to the boundary with Sub Chief Nyaluwanga and take Thoto river to the Lake

(d) **Nkhata Bay West**

The western part of Nkhata Bay District comprising areas lying between Kajilirwe River in Chief Kabunduli to the boundary with Sub-Chief Zilakoma in the south.

(e) **Nkhata Bay North West**

The north western part of Nkhata Bay District comprising the northern part of Chief Kabunduli's area from Kajilirwe River to Kaning'ina Forest, including the remaining areas of Chief Timbiri.

(f) **Nkhata Bay South East**

The south eastern part of Nkhata Bay District comprising whole areas of Chief Mankhambira, Sub-Chief Fukamalaza and Sub-Chief Malanda in Chief Malengamzoma, the new boundary being along Kande River.

(g) **Nkhata Bay South**

The southern part of Nkhata Bay District comprising the areas of Chief Malengamzoma, Chief Fukamapiri and Sub-Chief Zilakoma.

MZIMBA

Number of Registered Voters- 272,908

Number of Estimated 1998 Population - 523,028

Number of Eligible Voters (18 years +) - 252,228

The Commission visited Mzimba District on 22nd October, 1998, in order among other things, to review constituency boundaries in the district. Currently there are twelve constituencies in the district. The local leaders have requested eight additional constituencies in order to overcome communication problems and physical characteristics of the areas, and thereby facilitate manageability of the constituencies and enhance development.

After considering the requests, the Commission prescribes that the constituencies in Mzimba District should be delimited as follows:-

(a) **Mzuzu City**

The whole area of Mzuzu City.

(b) **Mzimba North**

The western part of Njakwa Mountain Ridge in the northern part of Mzimba

District running along Rukuru River to Kazuni and the central part of Inkosi Mtwalo.

(c) **Mzimba Njakwa (New)**

The northern part of Mzimba District comprising the area of Inkosi Jaravikuba, Njakwa mountain ridge, including Engucwini, Madisi, and Luhomero.

(d) **Mzimba Solora**

That part of Mzimba District comprising the areas of these centres: Milala, Ngoli, Mtenthe, Mtelemuka, St Francis, Manyamula, Mabazi, Embambeni, Mharaunda, Themhani, Kavutukutu Chanjovu etc.

(e) **Mzimba Perekezi (New)**

That part of Mzimba District comprising the areas of these centres: Viply, Kamwaphindi, Kabuku, St Pauls, Davy, Mzimba LEA, Mzimba DEC, Emazwini, Chamunguluba, Ematheni, Mziza etc.

(f) **Mzimba West**

The western part of Mzimba District comprising the areas of Inkosi Mpherembe.

(g) **Mzimba Kasito (New)**

The western part of Mzimba District comprising Inkosi Mtwalo areas of Elangeni, Chinyera, Kafukule, including the eastern part of Inkosi Mpherembe's area up to Bowe centre bordering Rumphu District.

(h) **Mzimba South**

The southern part of Mzimba District comprising the whole area of Inkosi Mzukuzuku.

(i) **Mzimba Wasozi (New)**

The southern part of Mzimba District comprising the Area of Inkosi Mzikubola.

(j) **Mzimba South East**

The south-eastern part of Mzimba District comprising the area of Inkosi Khosolo Jere.

(k) **Mzimba Mhoma (New)**

The south-eastern part of Mzimba District comprising the remaining area of Inkosi Khosolo Jere determined by the new boundary running through Phazi - Lupachi - Dwangwa - Luwerezi - Mwache.

(l) **Mzimba Luwelezi**

Comprising part of Inkosi Mabulabo's area.

(m) **Mzimba Elangeni (New)**

Comprising the remaining part of Inkosi Mabulabo's area determined by the new boundary to run through Mkazimasika Kakwere - Kanjuchi - Luwerezi to Njewa.

(n) **Mzimba Central**

The central part of Mzimba District comprising Euthini North Council Ward, Euthini Central Ward and Euthini West Ward in Chief Chindi's area.

(o) **Mzimba North-East**

The north-eastern part of Mzimba District comprising Luhomero, Njuyu, Chombongondo, Kafulufulu, Ekwendeni, Enyezini including Ekwendeni Mission Station, Nkhorongo Choma Malivenji and Doroba in Chief Mtwalo's area.

(p) **Mzimba South-West**

The south-western part of Mzimba District comprising the area of Inkosi Ya Makosi M'Mbelwa including Kapopo Mhlanga Ward in Inkosi Ya Makosi M'Mbelwa but excluding M'Mbelwa East Ward, M'Mbelwa South Ward and M'Mbelwa Central Ward.

(q) **Mzimba Hora**

That part of Mzimba District comprising Euthini East Council Ward, Euthini South Council Ward in Chief Chindi's area and South Council ward in Inkosi Ya Makosi Makosi M'Mbelwa including Jandalala in Inkosi Mtwalo.

KASUNGU

Number of Registered Voters- 180,462

Number of Estimated 1998 Population - 476,018

Number of Eligible Voters (18 years +) 230,325

The Commission visited Kasungu District on 22nd October, 1998, in order, among other things, to review the constituency boundaries. There are currently nine constituencies in the district. The local leaders have asked for four additional constituencies citing vastness of constituencies and high population as reasons.

After considering the request, the Commission is of the view that only three new constituencies be created therefore the Commission prescribes that the constituencies in Kasungu District should be delimited as follows:-

(a) **Kasungu North**

The northern part of Kasungu District comprising the area of Sub-Chief Chisikwa and Chief Kaluluma.

(b) **Kasungu North North East**

The north north eastern part of Kasungu District comprising the whole areas of Sub-Chiefs Simulemba and Nyanja.

(c) **Kasungu North West**

The north-western part of Kasungu District comprising the area of Chief Chulu.

(d) **Kasungu Central**

The central part of Kasungu District comprising Kasungu Township and the areas starting from Lisasadzi Bridge following Chibwe Stream to Kalinde down westwards to Dwangwa River, then following Chitete River, joining Nthema Stream going south-east to Lisasadzi River. These incorporate the following Council Wards: Chilanga Council Ward, Kasungu-Chipala Council Ward in Chief Kaomba's area and Chibophe Council Ward in Sub-Chief Chilowamatambe's area.

(e) **Kasungu East**

The eastern part of Kasungu District comprising Chamame and Kapyanga in Chief Wimbe.

(f) **KasunguKachokolo (new)**

The remaining area in Chief Wimbe

(g) **Kasungu South**

The southern part of Kasungu District comprising the area of Chief Santhe to Kasungu-Mchinji road.

(h) **Kasungu South-West (new)**

The remaining area of Chief Santhe from the Kasungu-Mchinji road.

(i) **Kasungu West**

The western part of Kasungu District comprising the Areas of T.A. Kawamba and S.T.A.Nthunduwala.

(j) **Kasungu South-South West (new)**

The south south western part of Kasungu District comprising the areas of T.A.Lukwa and T.A.Mwase.

(k) **Kasungu South East**

The South-eastern part of Kasungu District comprising the remaining area of Sub-Chief Chilowamatambe and the area of Sub-Chief Njombwa.

(l) Kasungu North East

The north eastern part of Kasungu District comprising the area of Chief Kapelula.

NKHOTAKOTA

Number of Registered Voters- 87,841

Number of Estimated 1998 Population - 230,361

Number of Eligible Voters (18 years +) 111,180

The Commission visited Nkhotakota District on 23rd October, 1998, in order, among other things, to review constituency boundaries. There are currently five constituencies in the district. The local leaders have asked for one additional constituency out of Nkhotakota South East constituency.

After considering the request, the Commission prescribes that the constituencies in Nkhotakota District should be delimited as follows:-

(a) Nkhotakota North

The northern part of Nkhotakota District comprising the area lying between Dwambadzi River and Dwangwa River in Chief Kanyenda. From the Lakeshore Road bridge take the old Dwangwa River bed to the Lake.

(b) Nkhotakota North East

The north eastern part of Nkhotakota District lying between Dwangwa River and Bua River in Chief Kanyenda's area.

(c) Nkhotakota Central

The central part of Nkhotakota District comprising the northern area of Chief Malengachanzi and the whole area of Sub-Chief Mphonde but excluding Linga Council Ward in Chief Malengachanzi stretching from Bua River to

Nkhotakota/Ntchisi Road to the Lake.

(d) **Nkhotakota South**

The southern part of Nkhotakota District comprising the remaining part of Chief Malengachanzi from Linga Council Ward to Lifuliza River.

(e) **Nkhotakota South-East**

The south eastern part of Nkhotakota District comprising the whole area of Chief Mwadzama.

(f) **Nkhotakota South West (new)**

The western part of Nkhotakota District comprising the whole area of Sub-Chief Mwansambo including part of Chief Mwadzama from upper Likowa River down to Kayoyo Turn-off and turn southwards through Katonya to Chiruwa River.

NTCHISI

Number of Registered Voters- 56,893

Number of Estimated 1998 Population - 167,353

Comprising Nkolokoti Council Ward, Mapanga Council Ward, parts of Limbe Central East and West Council Wards lying North of Kenyatta Drive and Churchill Road and Chichiri Council Ward.

(h) Blantyre Bangwe (new)

Comprising Bangwe Council Ward, Mzedi Council Ward and parts of Limbe East Council Ward.

(i) Blantyre West

Comprising the whole of Chief Kunthembe's area.

(j) Blantyre Chilangoma (new)

Comprising the whole of Chief Kuntaja's area.

(k) Blantyre North

Comprising the whole of Chief Chigaru's area.

(l) Blantyre Linjidzi (new)

Comprising the whole of Chief Lundu's area.

(m) Blantyre North East

Makata Road and all the area to the West of Blantyre-Chileka Road.

(e) Blantyre City West

The Western part of the City of Blantyre comprising Chilomoni Council Ward, Nancholi Council Ward, Michiru Council Ward , Blantyre West Council Ward and Likhubula Council Ward.

(f) Blantyre Kabula

Comprising South Lunzu Council Ward and parts of Nyambadwe Ward.

(g) Blantyre City East

Comprising Nkolokoti Council Ward, Mapanga Council Ward, parts of Limbe Central East and West Council Wards lying North of Kenyatta Drive and Churchill Road and Chichiri Council Ward.

(h) Blantyre Bangwe (new)

Comprising Bangwe Council Ward, Mzedi Council Ward and parts of Limbe East Council Ward.

(i) Blantyre West

Comprising the whole of Chief Kunthembwe's area.

(j) Blantyre Chilangoma (new)

Comprising the whole of Chief Kuntaja's area.

(k) Blantyre North

Comprising the whole of Chief Chigaru's area.

(l) Blantyre Linjidzi (new)

Comprising the whole of Chief Lundu's area.

(m) Blantyre North East

(b) Chiradzulu South - East (Namitambo) (new)

The south eastern part of Chiradzulu District comprising of Mitumbila Council ward, Nsoni Council ward, Mambala Council ward and Chikungulu Council Ward in Traditional Authority Kadewere.

(c) Chiradzulu - South West

The southern western part of Chiradzulu District comprising Sendekwe Council ward, Chilimankhwanje Council ward, Malabvi Council ward and Mbombwe Council ward in Chief Likoswe, the boundary being the western side of the main tarmac road from City Boundary (Yasini) towards the Boma up to PIM-turn off to Chimpesa school via PIM mission.

After considering the request, the Commission prescribes that the constituencies in Mwanza District should be delimited as follows-

(a) **Mwanza East**

The eastern part of Mwanza District comprising the whole area of Chief Symon Likongwe.

(b) **Mwanza North East**

The north eastern part of Mwanza comprising part of T.A. Mlauli covering group Village Headmen: Magaletta, Dzomoya, Makanani, Golden, Chimpanzi, and part of T.A. Dambe covering the area of Group Village Headman Soka.

(c) **Mwanza North**

The northern part of Mwanza District comprising the areas of Chief Dambe and Chief Ngozi.

(d) **Mwanza West**

The western part of Mwanza District comprising the whole area of Chief

Nthache.

(e) **Mwanza Central**

The central part of Mwanza District comprising the whole area of Chief Kanduku.

PHALOMBE

The Commission visited Phalombe District on 10th October, 1998 in order, among other things, to review the constituency boundaries. Phalombe was declared an autonomous district from Mulanje in 1997 and it is necessary to review its constituencies. Currently there are four constituencies in the new district, all named after Mulanje. The local leaders have requested three additional constituencies to facilitate supervision of development projects in view of the large population in the district.

After considering the request, the Commission prescribes that the constituencies in Phalombe District should be delimited as follows:-

(a) **Phalombe Central**

The Central part of the district comprising the areas of Group Village Headmen Nalingula, Mkhumba, Chimenya, Mphonde and Ndugunya.

(b) **Phalombe South**

The southern part of the district comprising the areas of Group Village Headmen Bwanaisa, Kaledzela, Kuchombe, Manjalende and Nyambalo.

Comprising the areas of Group Village Headmen Maoni, Namalima, Thunga, Chabuka, Nampinga nad Chabe.

(d) **Phalombe North**

After considering the request, the Commission prescribes that the constituencies in ~~Mulanje~~ District should be delimited as follows:-

(a) **Mulanje North West**

The north western part of T.A. Juma north of Thumbwe / Chisawani River.

(b) **Mulanje North**

The northern part of Mulanje District comprising the area of T.A. Nkanda north of Likulezi River.

(c) **Mulanje West**

The remaining part of T.A. Juma's area.

(d) **Mulanje Chambe**

The central part of Mulanje District bordering Likulezi River in the north and Chikonde River in the West in T.A. Nkanda's area.

(e) **Mulanje Pasani**

The remaining part of T.A. Nkanda's area.

(f) **Mulanje South West**

The south western part of Mulanje District comprising the whole area of Chief Mthiramanja.

(g) **Mulanje Central**

The central part of Chikwawa District comprising the west bank areas of Shire River of Chief Maseya and Chief Katunga.

(c) **Chikwawa Mwanza**

The area stretching from Nkombedzi River to Mwanza River to the south of Chikwawa Central constituency.

(d) **Chikwawa North West**

The area stretching from Chimwanjale River to the east ending at the Mozambique border to the west and Mwanza District in the north.

(c) Nsanje Nyamithuthu (New)

Comprising the area from Namiyala, stream to the south to former Chikapa Court in T.A. Tengani's area in the north to Bwangu and Kaloga in T.A. Mbenje's area.

(d) Nsanje Lalanje

Comprising the area from Chikapa Court, Mchacha 6 and Sorgin.

(e) Nsanje South

Comprising the areas of Chief Ndamera and Chief Nyachikadza.
